

# EXAMINATION AND INTERNAL ASSESSMENT PROCESS

# Overall Examination Process: Overview:

Students evaluation is segregated in two main parts:

- Theory for 60 marks
- Internal assessment for 40 marks

The total assessment will be out of 100 marks

### **Examination Process: Theory**

- Theory paper (written exam) will focus to evaluate writing skills, time management and understanding of the students. 60 marks in each subject are for theory.
- Out of the 60 marks,
  - 50 marks are allocated to end-term exam, &
  - 10 marks are assigned to the mid-term.

Mid-term session will be conducted in the middle of the session and the end-term exam will be based on complete syllabus and will be held at the end of the session /semester.

# Examination Process: Internal assessment

- The internal assessment is the continuous assessment process in which the student vocal, presentation, personality, etc skill are developed and further evaluated by the respective subject teacher.
- Internal assessment carries total of 40 marks, which includes:
  - Project (along with voice via) for 15
  - Moot Court for 15
  - Weekly assessment for 10

### **Examination Process**

- The examination process will be followed in all subjects.
- Every student will have to clear both the exams Theory & Internal assessment individually.
