Adequate reference books are available in With regard to the feedback received on the adequacy of reference books in the library, approximately 47% of the students gave the feedback as being satisfactory to excellent.

> The feedback also includes about the nonavailability of books in some subjects at the beginning of each Trimester. As for the selection and purchase of books, a month and so is generally required with regard to the quotation, etc and as this was the first batch studying in the Faculty of Law their feedback to some extent was justified.

> In this regard every effort was made to purchase the books for the library but students could avail the same only after a delay of few weeks of the Trimester.

> The feedback given by the first batch was taken seriously and the subsequent batches did not have to face this problem.

> Further, the Faculty has taken the following steps for redressing the issues related to Library:

- a. Formation of a Committee to regularly look into the requirements of the Library and address the same.
- b. Regularly updating the Library with sufficient reading materials and books, based on the suggestion of the Committee designated.
- c. The process has already started and the Library is being updated.
