This Agreement is made and executed at Gurgaon on this 1<sup>st</sup> AUGUST 2023.

**SGT UNIVERSITY VILLAGE CHANDU, BUDHERA, GURUGRAM, HARYANA-122505**, having its registered office at VILLAGE CHANDU, GURUGRAM (H.R) - 122505 (Hereinafter referred to as SGT UNIVERSITY which expression shall unless it be repugnant to the subject or context hereof would mean and include its successors in interest, executors, administrators, liquidators and assigns) of the First Part, through its duly authorized signatory **Dr. Joginder Yadav, Registrar.**

And

**M/s GURGAON WASTE MANAGEMENT SYSTEM (P) LTD.** Having its office at U-15/6 DLF City Phase-3, Near R.B.S. Building Cyber City, Gurgaon-122001, Haryana (hereinafter referred to as '**SECOND PART**' which expression shall, unless repugnant to the context of meaning here of mean and include its representatives, successors in interest, executors, administrators, liquidators and permitted assigns), through its duly Authorized Signatory **Mr. Ram Narayan Roy** of the other part.

AND WHEREAS the SECOND PART has represented that they have approval for collection of garbage by the Municipal Corporation, Gurgaon. They have offered their services for collection/transportation of **Dry and Wet Waste** SGT UNIVERSITY has accepted the request of SECOND PART on the terms and conditions set forth in this agreement.

**AND WHEREAS** it is deemed expedient to record the terms and conditions between the parties in this Agreement.

**NOW THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED, DECLARED COVENANTED AND RECORDED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS.**

1. That the SGT UNIVERSITY has agreed to engage SECOND PART, on terms and conditions contained hereinafter for collection of **Dry and Wet Solid Waste** (hereinafter referred to as 'Said Work') from SGT UNIVERSITY Gurgaon and disposal as mentioned above specified place.
2. This agreement will be effective from **1st AUGUST 2023** and shall be effective till **31st JULY, 2024**, unless terminated earlier as per the terms and conditions of the agreement. SGT University may terminate this agreement by written notice to second part with immediate effect if second part commits a material breach of any of its obligations under this agreement. This agreement may also be terminated at any time by the University with 30 (Thirty) days prior written notice to second part in case of termination under this clause the accrued rights and obligations of the parties shall continue.
3. The FIRST Part will pay an amount of Rs. **35,000/- (Thirty-Five Thousand only) GST 18%** extra to the GURGAON WASTE MANAGEMENT SYSTEM PVT LTD. against collection of **Dry and Wet Waste** charges per month and payment to be made by 7<sup>th</sup> of the preceding month.
4. That second part shall employ labours/workers with a proper dress, Logo, identity cards properly displayed, and workers/labours so employed should be polite courteous in their behavior while collecting garbage from SGT UNIVERSITY.
5. The vehicles provided by the second part to the workers employed for collecting **Dry and Wet Waste** should be in workable/running conditions and waste should be properly covered/packed and labelled while transporting/collecting.
6. That all vehicles engaged by the second part should be of one-color code with detailed name plate of contractor i.e., second part, with segregation labels of WET and DRY Waste.

7. The second part will be penalized if he failed to collect the waste, or any breach of terms and conditions stipulated in the agreement with SGT UNIVERSITY.
- 8.. That SECOND PART shall use its best skills and judgments and shall perform all services timely, diligently and to the reasonable satisfaction of the SGT UNIVERSITY in a whole.
9. That the SECOND PART shall provide the service diligently and in conformity with the applicable laws and regulations. SECOND PART shall carry out the service in under the supervision of SGT UNIVERSITY.
10. That the services to be provided by the Second part are detailed in this agreement. However, it is expressly understood between the parties that scope of work is only indicative of the services to be provided by Second part and not an exhaustive list of the services to be provided by the Second part and the SGT University will be entitled to add more services in the scope of the work.
11. That SECOND PART undertakes to fulfill all the formalities and requirements of Government of India, Ministry of Environment and Forest and Municipal Corporation, Gurgaon.
12. SECOND PART shall ensure that the waste is taken in Truck/Tractor Trolley daily as per convenient timings. SECOND PART agrees to keep SGT UNIVERSITY indemnified and harmless for the area/building occupied/used by SECOND PART in this respect.
13. SGT UNIVERSITY has permitted SECOND PART for collection of waste from the Demised Premises. It is made clear that any violation of these conditions shall entitle SGT UNIVERSITY to terminate this permission/agreement and to recover the cost of damages, any other charges etc. from SECOND PART to make as good including restoration work etc.
14. SECOND PART shall pay if any penalty is imposed for dumping waste at any unauthorized place.
15. If waste is not collected regularly by SECOND PART, penalty on pro-rata basis shall be imposed by SGT UNIVERSITY on SECOND PART.
16. The SECOND PART shall be liable/responsible for filing all statutory returns/forms statements under various labour laws, acts and the rules made there under as applicable from time to time and for depositing all government/with the concerned authorities/government agencies and shall also ensure that the provisions of payment of Minimum Wage Act and any other Act(s), legislation(s) and the Rule(s)

made thereunder, as applicable from time to time, are not violated in the respect of his personnel/employee/worker/labour deputed/deployed by him for executing the said work(s) and SGT UNIVERSITY shall in no way be responsible for the SECOND PART, of whatever nature, arising under various labour laws and any other Act(s) legislation(s) and the rule(s) made thereunder.

17. That the SECOND PART will not engage any sub-contractor for executing the said work under this agreement without written permission from SGT UNIVERSITY.

18. SECOND PART shall immediately attend to any and all complaints of SGT UNIVERSITY regarding the working & behavior or personnel deputed/deployed by him.

19. SECOND PART shall be deputing their personnel with Identity Card issued by the Organization. Police verification should also be got done from the Gurgaon Police authorities & submitted with SGT UNIVERSITY.

20. SECOND PART shall be fully responsible for any mishap and the safety of SECOND PART staff as well as all equipment connected with SGT UNIVERSITY.

21. SECOND PART shall not supply or show the copy of this permission/agreement to any other organization or to its client(s) or to the client(s). SGT UNIVERSITY shall retain the original of this permission/agreement and SECOND PART shall provide with a carbon/photocopy thereof by SGT UNIVERSITY.

22. That the representative of the SGT UNIVERSITY Shall observe the loading of the vehicle when waste is taken from the Demised Premises.

23. SECOND PART shall ensure that people handling waste collection from SGT UNIVERSITY have adequate training and knowledge of type of garbage being handled. The SECOND PART shall ensure that the vehicle for transportation of waste is in perfect condition and the driver has valid driving license and other permission and necessary papers.

24. That if any material is found to be taken out by SECOND PART except permitted, SGT UNIVERSITY have the sole right to cancel the agreement with immediate effect.

25. That the SECOND PART represents that they have the specialization to handle garbage. That the SECOND PART undertakes to indemnify and keep indemnified the SGT UNIVERSITY in case of any misuse, mishandling, pilferage, its employee, agents and/or any authorized person thereof resulting in any penalty, liability and damages under any rule, regulation, Acts, Notification imposed by the authority concerned.

26. The courts at Gurgaon and/or the Punjab & Haryana High Court at Chandigarh alone shall have the jurisdiction in this matter. Any action brought in connection with this agreement shall be resolved by arbitration as set forth in the following paragraph.

If any dispute, difference, claim or controversy including the matter of damages if any (collectively referred to as "Dispute") arises between the parties about the validity, interpretation, implementation or alleged breach of any provision of this agreement, or any thing connected or related to or incidental to this Agreement then the parties shall negotiate in good faith to endeavor to resolve the matter. However, if the dispute has not been resolved by the parties within fifteen (15) days after the date of the receipt of written notice of the dispute by either party from the party raising the dispute, then either party may submit the dispute to arbitration to be conducted in accordance with the provisions of the Indian arbitration and Conciliation Act 1996, as amended from time to time. Arbitration shall be held at Gurugram, Haryana. The dispute shall be referred to a sole arbitrator appointed by SGT University. The arbitration proceedings shall be conducted, and the award shall be rendered in English language. The award rendered by the arbitrator or arbitrators shall be final, conclusive, and binding on the parties to this agreement and shall be subject to enforcement in any court of competent jurisdiction. Each party shall bear the cost of arbitration.

27. Both the parties acknowledge and agree that the relationship created by this agreement is, and is intended to be, that of independent, contractors and on principal-to-principal basis and is not intended to be and shall not be construed to be a partnership franchise or a consignee for any purposes whatsoever. This agreement does not constitute, nor shall be construed to so constitute, either party as an employee, agent, representative, consignee, partner or joint venture partner of the other party for any purpose whatsoever.

SERVICE AGREEMENT

The Agreement is entered into on this 30th Day of March 2023 at Haryana.

**BY AND BETWEEN**

**Biotic Waste Ltd.** having its treatment facility at **Plot No.725, Pace City-11, Sec-37 Gurugram, Haryana** and its regd. office at (hereinafter referred to as "**First Party**") which expression shall, unless contrary to and/or repugnant to the context mean and include it's successors, representatives and permitted assigns) through **Mr. Anup Yadav** to enter into and sign this agreement for and on behalf of the **First Party**.

**AND**

**M/s-SGT University, Gurugram, Haryana including SGT Medical College, Hospital & Research Institute, Gurugram, Haryana** (hereinafter referred to as "**Second Party**") which expression shall, unless contrary to and / or repugnant to the context mean and include its successors, representatives and permitted assigns) through its authorized representative **Registrar, Dr. Joginder Yadav** of the **Second Party**.

## WHEREAS

The **First Party** has been authorized by the **Haryana State Pollution Control Board (HSPCB)** of the Bio-Medical Waste Rules, 2016 for operating a facility for the **Collection, Reception, Transportation, Treatment and Disposal of Bio-Medical Waste in Haryana.**

The **Second Party** in compliance of the Bio-Medical Waste (Management & Handling) Rules, 2016 desired to have services for disposal of their Bio-Medical Waste (except liquid bio-medical waste) for which the First Party is authorized facility of HSPCB.

NOW THIS AGREEMENT witnessed the following terms & conditions to be performed by both the parties to the agreement.

1. The First Party will require the Second Party's representative to sign its Daily Bio Medical Waste (hereinafter referred to as "BMW") Collection Sheet to acknowledge handing over of Bio-Medical Waste to First Party. The First Party's Staff will sign the Record Book to be maintained by the Second Party in acknowledgement of waste collected. Maintenance of the said Record Book by the Second Party is a statutory requirement and has to be complied with.
2. The Second Party will arrange for the collection of BMW, and ensure proper segregation of Bio-medical Waste generated from its various department/wards, as per Bio-medical Waste (Management and Handling) Rules, 2016. The Second Party also ensures that all the Bio Medical Waste i.e. incinerable and autoclavable waste (including plastic waste) is handed over to First Party. All infected material including culture plates, laboratory sample (autoclavable) shall be segregated in yellow colored bags as per BMW Rules at user level and given to First Party.
3. The Second Party will pack the segregated Bio-Medical waste as per rules, at the collection end point, in Color Coded Bags, label the bags as per Schedule IV (Rule 6) of the Bio- Medical Waste Rules, 2016 and keep them ready for collection by First Party's collection staff during 6 a.m. to 10 p.m. or any other time which may be mutually agreed upon.
4. **The Second Party will itself arrange for all color coded bags as per BMW Rules to be used for internal segregation and for their end point purposes.**
5. The Second Party undertakes to deliver to the First Party only the segregated Bio-Medical Waste generated on daily basis. Bags should be duly labeled as per Schedule IV, signed and tagged General Waste i.e. (MUNICIPAL SOLID WASTE IS NOT TO BE PUT INTO THE COLOUR CODED BAGS AT ALL). For any violation of the Bio-Medical Rules in this regard the Second Party shall be exclusively responsible.
6. The Second Party's responsibility will cease once the segregated bio-medical waste, duly packed, labeled and signed, has been handed over to the First Party. It is

specifically agreed and understood that compliance of the Bio-medical Waste (Management & Handling) Rules 2016 during transportation and disposal of Bio-Medical Waste shall be the exclusive responsibility of the First Party. The Second Party will be solely responsible for compliance of Bio-Medical Waste Rules, 2016 in respect of their liquid bio-medical waste.

7. The First Party will charge the Second Party being a Private organization having 878 Teaching Beds + Critical Care & Day Care beds facilities, Rs 2,31,792/- + 27,815/- (GST@ 12%) = Rs 2,59,607/- (Two Lakh Fifty Nine Thousand Six Hundred and Seven Only) Monthly subject to maximum quantum of 8560 Kg/ Month from 01 April 2023 to 31 March 2024. BMW collected in excess of agreed quantity will be charged @ Rs. 35 per Kg extra. The charges for the first month shall be payable at the time of signing of agreement and service tax will be charged over and above the aforesaid amount as per government rules.

8. Apart from one month charges payable at the time of signing of agreement as per clause 7 above, the late fee Rs. 200 per month, in which the payment is due, would be charged by the First Party if payment is not made within 10 day of the receipt of the bills or 10<sup>th</sup> of every month, whichever is later.

**9. Payment will be accepted only by Cheque /NEFT/RTGS. CASH PAYMENT WILL BE NOT ACCEPTED IN ANY CIRCUMSTANCES. If any payment made in CASH it will not be acknowledged by the First Party.**

10. Taxes, such as Contract Sales Tax, Service Tax etc., if applicable, shall be payable by the Second Party.

10. (a) Notwithstanding the aforesaid terms this Agreement may be terminated by either party by giving 90 days written notice. However this requirement of 90 days notice shall not be applicable upon the occurrence of any of events specified in Clause 10 b, in which events the service would be suspended/ terminated forthwith.

10. (b) Notwithstanding the aforesaid term. The First Party will be within their rights to suspend the services to the Second Party in the event of the Second Party handing over un-segregated Bio- Medical Waste or for nonpayment within Thirty days of submission of the bill. After termination of agreement the First Party shall inform the Haryana State Pollution Control Board in writing regarding cancellation of agreement.

11. Neither party shall transfer or assign the right granted under this Agreement without the prior intimation to and permission from the other party and without obtaining a written undertaking by the proposed assignee/transferee agreeing to assume all of the said party's obligations under this Agreement and to abide by all the obligations and covenants contained herein.

12. In the event of any increase in the prices of diesel, petrol, CNG, electricity etc. or in minimum wages payable to employees as per Minimum Wages Act or any other

circumstances that affect the transportation/disposal cost of Bio-Medical Waste during the substance of this agreement, the First Party shall be entitled to enhance rates, which shall be fixed by mutual agreement between the parties.

13. No change of modification or waiver of any of the terms of this Agreement shall be effective unless agreed to in writing and signed by a duly authorized officer of each of the parties hereto.

14. This agreement shall be governed by the laws of India and shall be interpreted and construed in accordance with the laws of India and the Courts at Gurugram, Haryana alone shall have exclusive jurisdiction to try, entertained and dispose of any dispute between the parties hereto.

15. All notices, requests, demands and other communications required/ permitted to be given under this Agreement shall be in writing and delivered by hand against receipt, or sent by registered mail or by telex at the following address.

Any such notice or communication shall be deemed to have been duly given and served at the date and time of (1) delivery or of first refusal of delivery, if sent by registered mail or delivered by hand; or (II) either the date sent (if sent during the receiving party's normal business hours) or next succeeding business day, if sent by telefax.

16. If occupier fail to submit the PCB Authorization in a Month's time from the date of agreement then agreement will be null and void.

17. Both the parties shall strictly follow the guidelines of the Bio- Medical Waste Management Rules 2016, during Segregation, Collection, Transportation and Disposal of the bio- Medical Waste except due to the circumstances under force majeure clause and the circumstances beyond their control of the parties.

18. In the event of any dispute, disagreement, complaint or difference between the Parties, in respect of or concerning or connected with the interpretation or implementation or arising out of this Agreement or any Clause or provision hereof, or relating to the termination hereof (a "Dispute"), then such Dispute shall in the first instance be resolved amicably by both the parties. In the event that the Parties are unable to mutually resolve the Dispute within 15 (Fifteen) Business Days of the Dispute

being raised before either of the Parties referred to it, the same shall be referred to sole arbitrator appointed jointly by both the parties in accordance with the Indian Arbitration Act, 1996 for the time being in force. The language of the arbitration shall be English. The seat and venue of arbitration shall be at Gurugram and the local laws of Gurugram (Haryana) shall be applicable.

19. The term of this Agreement shall be commencing from **01/04/2023** and terminating on **31/03/2024** and the Agreement thereafter may be renewed for such further period and on such terms and conditions as may be mutually decided by the parties.
